Secretary's Report:

Larry H. made a motion to approve the Organization & Membership report. Motion approved by all directors present.

Promotion & Tourism:

Renee B. provided a report for the Promotion & Tourism committee which was distributed to all Chamber members via email prior to the meeting. Discussion included the Chamber's donation to Off N' Funning being changed to the Apple Affair budget. Local businesses expressed favorable and unfavorable views regarding the coordination of the Galesville City Wide Garage sale within the 100 mile garage sale. The committee has the next Galesville City Wide Garage sale planned for the second Saturday in September and intends to advertise all dates provided by participants even though the Chamber officially sponsors Saturday. Farmer's market vendors will need to pay full price if they want to participate in sales at Apple Affair. Tammy P made a motion to accept the Promotion & Tourism report. Motion approved by all directors present.

Sarah L. provided a report with website statistics which was distributed to all Chamber members via email prior to the meeting. The website hits continues to increase with 7461 hits during the month of April 2016. Tammy P made a motion to accept the website report. Motion approved by all directors present.

Economic Revitalization & Development:

Sharon S provided a report for the Economic Revitalization & Development committee which was distributed to all Chambers members via email prior to the meeting. Topics noted included a need for more restaurant options, a need for local housing, local room tax, businesses being closed on Mondays, promoting commercial and industrial growth, and providing support for "The Go Fund Me Page" for "the Building On The Corner" by identifying compatible potential businesses to rent space. Larry H made a motion to accept the Economic Revitalization & Development report. Motion approved by all directors present.

Agri-Business:

Richard T. provided a report for the Agri-Business committee which was distributed to all Chamber members via email prior to the meeting. A farmer's market invitation and application are posted online for vendors. A few vendors requested to start the farmer's market earlier. Todd Peterson told Richard that he does not like the idea of bike racks due to difficulties with mowing. The annual farmer's market meeting is scheduled for May 30,

Motion approved by all directors present.

Historic Preservation, Beautification & Design:

Chris P provided a report for the Historic Preservation, Beautification & Design committee which was distributed to all Chamber members via email prior to the meeting. The report included a list of various upcoming events at the Arnold House and Old Main. Chris P verbally encouraged everyone to support these events and future events including Founder's Day on June 25, 2016 which was not noted on the report. Larry H made a motion to accept the Historic Preservation, Beautification & Design report. Motion approved by all directors present.

Old Business:

- a. Chamber ambassador/advocate to City Council. A motion was made by Lindsay S to appoint Sarah L as the Chamber's advocate to attend the Galesville City Council meetings. Motion approved by directors present except Sara L did not express her approval or denial of the motion.
- b. Trempealeau County Agricultural Society
 - a. Booth at Trempealeau County Fair – Renee B noted in the Promotion & Tourism committee report that only Chamber members will be displaying items at the booth. Tammy P volunteered Jeff's Service as a drop off location for marketing materials for the booth. Melanie verbally noted that Chamber members should start bringing marketing items to the June 8, 2016 Chamber meeting.
- c. Annual farmer's market vendors at Apple Affair. Renee B noted in the Promotion & Tourism report that farmer's market vendors need to pay the same amount as a craft vendor for the day.
- d. Local room tax. Sharon S verbally noted that she approached local businesses which expressed various feelings on the local room tax. This discussion will continue in the Economic and Development committee meetings. Lindsay expressed a large increase in accounting time would be created by these funds and a paid position should be considered. This has not been added to the City of Galesville agenda yet.

- d. As president of the Chamber, Sarah L appointed Lori Severson to the current board vacancy which term ends December 31, 2016. Lori introduced herself to those in attendance while the board of directors and Chamber members followed with introductions.
