This annual event, since 1983, is growing and has struggled with safely accommodating the increasing number of tourists, shoppers, bicyclists, and vendors who attend each year and still allowing us to showcase our historic downtown, explore local history at A.A.Arnold House/Eastside Farm, discover our apple orchards and promote regional arts at Old Main Historical Community Arts Center.
