Historic Preservation, Beautification & Design:

Chris P. provided a verbal report on the upcoming Founder's Day. Due to planning Founder's Day, the committee did not have a meeting. Chris P is going to help Sarah L contact Alex regarding the Chamber obtaining Gale Star promotional information to be posted on the Chamber's website. Chris P plans to research the cost and details of acquiring "brown signage" for the Arnold House with the potential for other locations. Chamber directors expressed that they would like to see improvements to the City of Galesville entryway gardens. Suggestions of contacting the local Garden Club or the new owners of Sunset Gardens were mentioned. Discussion expressing concern for the non-prominent signage on the closed High Cliff trail was noted. The trail has been closed by the City due to several large rocks that have fallen. Possible safety improvements mentioned were a "CAUTION" ribbon across the trail, a bold-colored chain blocking the trail or a "Caution
